

RESOLUTION OF INTENT TO IMPOSE AN ADJUSTMENT IN LEVIES

As an essential part of its budgeting process, the Creston School Board of Trustees is authorized by law to impose levies to support its budget. The Creston School Board of Trustees estimates the following increases/decreases in revenues and mills for the funds noted below for the next school fiscal year beginning July 1, 2025, using certified taxable valuations from the current school fiscal year as provided to the district.

General – Base & OverBase – Est. decrease in revenues: \$41,441.00. Est. decrease in mills: 6.88. Est. decrease on a 100K home: \$9.29. Est. decrease on a 200K home: \$18.58.

Transportation – Est. increase in revenues: \$5,234.00. Est. increase in mills: 0.86. Est. increase on a 100K home: \$1.16. Est. increase on a 200K home: \$2.32.

Bus Depreciation – Est. change in revenues: \$0. Est. increase/decrease in mills: -0-. Est. increase/decrease on a 100K home: \$0. Est. increase/dec on a 200K home: \$0.

Tuition – Est. increase in revenues: \$173,032.00. Est. increase in mills: 28.70. Est. increase on a 100K home: \$38.75. Est. increase on a 200K home: \$77.50.

Technology - Est. change in revenues: \$0. Est. increase/decrease in mills: -0-. Est. increase/decrease on a 100K home: \$0. Est. increase/dec on a 200K home: \$0.

Flexibility - Est. change in revenues: \$0. Est. increase/decrease in mills: -0-. Est. increase/decrease on a 100K home: \$0. Est. increase/dec on a 200K home: \$0.

Building Reserve – Est. decrease in revenues: \$185.00. Est. decrease in mills: 0.03. Est. decrease on a 100K home: \$0.04. Est. decrease on a 200K home: \$0.08.

Total Est. change in revenues: \$136,640.00 increase. Est. increase in mills: 22.65. Est. increase on 100K home: \$30.58. Est. increase on a 200K home: \$61.16.

The District anticipates using the permissive building reserve levies listed above and state major maintenance aid to address facility and land maintenance, repairs and improvements; outdoor basketball court repair/replacement; sidewalk replacements; roofing repair/replacement over south portion of main building; septic system replacement.

This notice requirement is an estimate only. None of the budget changes have officially been adopted for the 2025-2026 school year. Action will not be taken on these items until final Budgets are approved.
